Purpose:

- To provide continuous cardiac monitoring for those patients who are ambulatory in the cardiac department.
- To record cardiac activity for diagnostic and documentation purposes
- · To enable the treatment of arrhythmias

Responsibility:

- RN in cardiac department
- RPN as per C.N.O. Standards. Refer to "A Decision Guide/Determining the Appropriate Category of Care Provider." (May 2009).

Equipment:

- ECG monitor (central and/or bedside monitor and/or telemetry)
- Telemetry Pack/Patient cable
- Lead wires
- Electrodes
- · Alcohol swabs
- Clippers

Method:

- Enter Patient's name, doctor & room number on the screen
- Place electrodes close to the limb-torso junction. This placement allows easier access for defibrillation, auscultation, CPR, etc.
- Obtain and analyze rhythm strip on admission, q shift and with any change in rhythm or in patient's condition
- Record rate and rhythm in electronic documentation q shift and PRN.
- Evaluate skin integrity daily and change electrodes q48h and prn

- Rotate electrode sites
- Telemetry for 24 hrs the MD or NP reassess daily.

When discontinuing telemetry:

- Remove pack from patient
- Remove electrodes
- · Remove battery from pack and discard
- Unassign patient from central monitor
- Store telemetry packs in designated area on unit after cleaning according to current infection prevention and control standards
